

## Annual Management Report of Fund Performance

### Management Discussion of Fund Performance

#### Investment Objective and Strategies

**Investment Objective:** Axiom Foreign Growth Portfolio (the *Portfolio*) seeks to achieve long-term capital growth by investing primarily in U.S. and international equity mutual funds that provide exposure to a number of industrialized countries outside of Canada, including countries in Europe, the Far East and Asia, and emerging market countries, with some global exposure to fixed income securities for diversification (its *Underlying Funds*).

**Investment Strategies:** The portfolio advisor has established a long-term strategic asset mix weighting for the Portfolio with, under normal market conditions, an asset mix of fixed income (0-25%) and equities (75-100%). The portfolio advisor may review and adjust the asset mix, in its sole discretion, depending on economic conditions and relative value of income and equity securities. The Portfolio will utilize strategic and tactical asset allocation strategies that will:

- invest up to 100% of the Portfolio's assets in units of its Underlying Funds managed by the Manager or one of its affiliates;
- allocate the Portfolio's assets among the Underlying Funds according to the asset mix determined by the portfolio advisor and monitor, review, and periodically rebalance or modify the Portfolio's asset mix, change the percentage holdings of any Underlying Fund, and add or remove any Underlying Fund at the portfolio advisor's sole discretion.

#### Risk

The Portfolio is a global equity balanced fund that is suitable for investors who can tolerate low to medium investment risk.

For the period ended August 31, 2018, the Portfolio's overall level of risk remained as discussed in the simplified prospectus.

#### Results of Operations

The Portfolio's portfolio advisor is CIBC Asset Management Inc. (CAMI, the *Manager* or *Portfolio Advisor*). The commentary that follows provides a summary of the results of operations for the period

ended August 31, 2018. All dollar figures are expressed in thousands, unless otherwise indicated.

The Portfolio's net asset value increased by 29% during the period, from \$8,300 as at August 31, 2017 to \$10,667 as at August 31, 2018. Net sales of \$1,359 and positive investment performance resulted in an overall increase in net asset value.

Class A units of the Portfolio posted a return of 12.7% for the period. The Portfolio's primary benchmark, the MSCI World Index (the *primary benchmark*), returned 18.3% for the same period. The Portfolio's blended benchmark (the *blended benchmark*) returned 14.0% for the same period. The blended benchmark closely reflects the asset classes in which the Portfolio invests, and is designed to provide a more useful comparative to the Portfolio's performance. The Portfolio's return is after the deduction of fees and expenses, unlike the primary and blended benchmarks' returns. See *Past Performance* for the returns of other classes of units offered by the Portfolio.

The Portfolio has a target asset allocation of 43% U.S. equities, 33% international equities, 14% global fixed income securities and 10% emerging markets equities.

U.S. equities were strong over the period, fuelled by positive economic data. Gross domestic product growth exceeded expectations and consumer confidence and manufacturing activity remained strong. Job creation was also strong, and inflation increased. In addition, oil prices rose significantly.

After declining by about 10% in the first quarter, the U.S. equity market recovered quickly, returning almost 20% for the period, despite increased market volatility. This increased volatility was largely a result of higher U.S. interest rates and continued escalation of trade tensions between the U.S. and its international partners, particularly China. The information technology sector recorded significant gains, while the utilities and consumer staples sectors were the weakest-performing sectors.

Non-U.S. developed market stocks returned positive performance for the period despite concerns about moderating growth in Europe and Japan, increased global political uncertainty and escalating trade tensions. The U.S. announced trade tariffs, targeting over \$50 billion USD in Chinese imports.

European equities rebounded during the first half of the period before geopolitical concerns and weakening economic data early in 2018 weighed on investor confidence. Equities in Japan gained overall. A first-quarter 2018 dip ended Japan's eight-quarter streak of positive economic growth, but its economy rebounded in the second quarter.

In global fixed income markets, global monetary policies diverged. The U.S. dollar outperformed most currencies as a result of U.S. economic growth, rising U.S. inflation, rising interest rates and trade tensions. This had a negative impact on commodity and trade-linked currencies and bonds. Rising U.S. interest rates and a strengthening U.S. dollar fell especially heavily on emerging markets with high debt or current account deficits.

The first half of the period was characterized by continued gains in emerging market equities. In the latter half, however, investors became concerned about trade policies and rising geopolitical tensions. Political issues in Brazil and Turkey caused investors to avoid those countries. Smaller market participants, such as Qatar and Thailand, produced the highest returns. Energy was the top-performing sector as crude oil prices rebounded.

From an underlying fund perspective, Renaissance Global Bond Private Pool was the most significant detractor from the Portfolio's performance relative to the blended benchmark, followed by Renaissance Emerging Markets Equity Private Pool.

Underlying fund Renaissance International Equity Private Pool was the most significant contributor to the Portfolio's performance, followed by Renaissance U.S. Equity Private Pool.

### **Recent Developments**

There were no recent events or activities that had a material impact on the Portfolio.

### **Related Party Transactions**

CIBC and its affiliates have the following roles and responsibilities with respect to the Portfolio, and receive the fees described below in connection with their roles and responsibilities.

#### *Manager, Trustee, and Portfolio Advisor of the Portfolio*

CAMI, a wholly-owned subsidiary of CIBC, is the Portfolio's Manager, Trustee, and Portfolio Advisor. CAMI receives management fees with respect to the Portfolio's day-to-day business and operations, calculated based on the net asset value of each respective class of units of the Portfolio as described in *Management Fees*. As Trustee, CAMI holds title to the Portfolio's property (cash and securities) on behalf of its unitholders. As Portfolio Advisor, CAMI provides, or arranges to provide, investment advice and portfolio management services to the Portfolio. CAMI also compensates dealers in

connection with their marketing activities regarding the Portfolio. From time to time, CAMI may invest in units of the Portfolio.

#### *Distributor*

Dealers and other firms sell units of the Portfolio to investors. These dealers and other firms include CAMI's related dealers such as the CIBC Investor's Edge discount brokerage division of CIBC Investor Services Inc. (*CIBC ISI*), the CIBC Imperial Service division of CIBC ISI, and the CIBC Wood Gundy division of CIBC World Markets Inc. (*CIBC WM*). CIBC ISI and CIBC WM are wholly-owned subsidiaries of CIBC.

CAMI may pay sales commissions and trailing commissions to these dealers and firms in connection with the sale of units of the Portfolio. These dealers and other firms may pay a portion of these sales commissions and trailing commissions to their advisors who sell units of the Portfolio to investors.

#### *Portfolio Transactions*

The Portfolio may undertake currency and currency derivative transactions where CIBC WM, CIBC World Markets Corp., or any affiliate of CIBC is the counterparty (the *Related Party Transactions*) in reliance on the standing instructions issued by the Independent Review Committee (*IRC*).

At least annually, the IRC reviews the Related Party Transactions for which they have issued standing instructions. The IRC is required to advise the Canadian securities regulatory authorities, after a matter has been referred to or reported to it by the Manager, if it determines that an investment decision was not made in accordance with conditions imposed by securities legislation or the IRC in any Related Party Transactions requiring its approval.

#### *Custodian*

CIBC Mellon Trust Company is the custodian of the Portfolio (the *Custodian*). The Custodian holds all cash and securities for the Portfolio and ensures that those assets are kept separate from any other cash or securities that the custodian might be holding. The Custodian also provides other services to the Portfolio including record-keeping and processing foreign exchange transactions. The fees and spreads for services of the Custodian are paid by CAMI and charged to the Portfolio on a recoverable basis. CIBC owns a 50% interest in the Custodian.

#### *Service Provider*

CIBC Mellon Global Securities Services Company (*CIBC GSS*) provides certain services to the Portfolio, including fund accounting and reporting, and portfolio valuation. Such servicing fees are paid by the Manager, and charged to the Portfolio on a recoverable basis. CIBC indirectly owns a 50% interest in CIBC GSS.

## Management Fees

The Portfolio pays CAMI an annual management fee to cover the costs of managing the Portfolio. Management fees are based on the Portfolio's net asset value and are calculated daily and paid monthly. Management fees are paid to CAMI in consideration for providing, or arranging for the provision of, management, distribution, and portfolio advisory services. Advertising and promotional expenses, office overhead expenses related to the Manager's activities, and trailing commissions are paid by CAMI out of the management fees received from the Portfolio. The Portfolio is required to pay applicable taxes on the management fees paid to CAMI. Refer to the simplified prospectus for the annual management fee rate for each class of units. No management fees or incentive fees are payable by the Portfolio that, to a reasonable person, would duplicate a fee payable by an Underlying Fund for the same service.

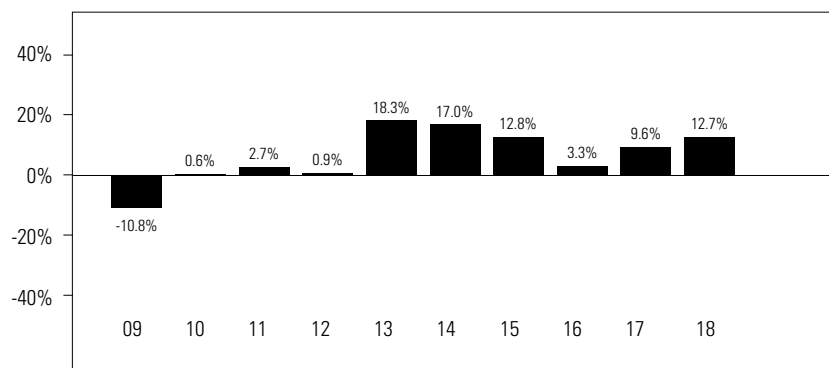

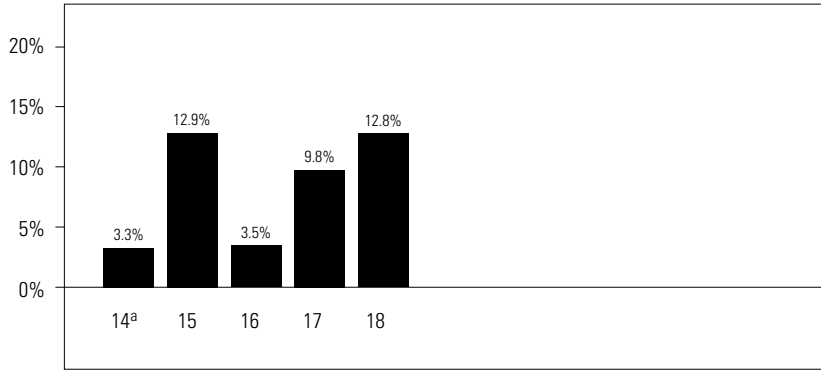

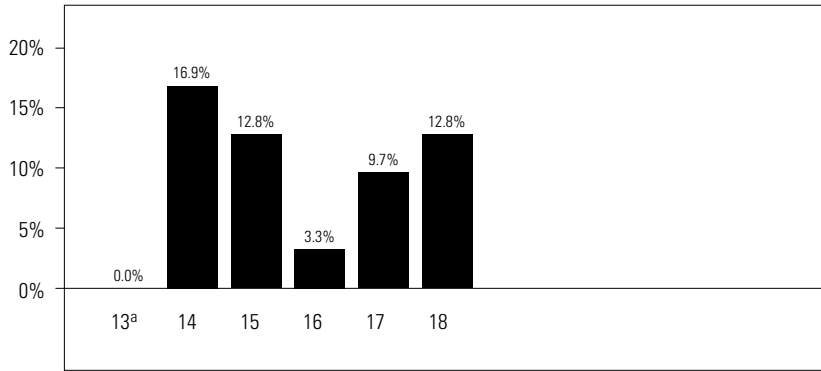


Class T4 Units



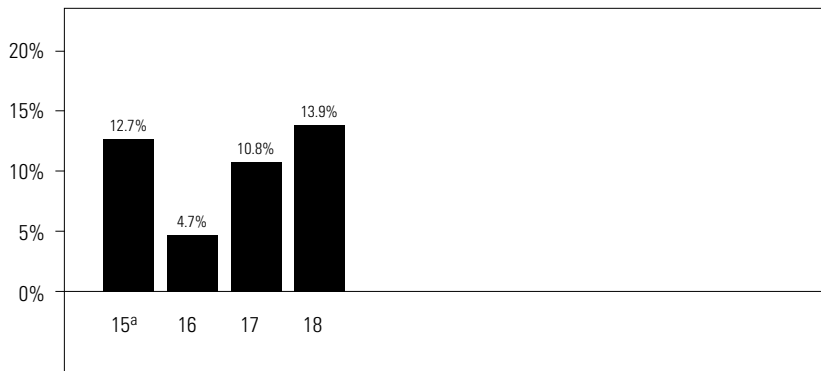
