This is Amendment No. 3 to the simplified prospectus dated September 1, 2016 (the "Simplified Prospectus"), as amended by Amendment No. 1 dated December 5, 2016, and Amendment No. 2 dated April 28, 2017, which should be read subject to this information.

All capitalized terms used herein and not otherwise defined shall have the same meanings given to such terms in the Simplified Prospectus.



## **SUMMARY OF AMENDMENTS**

CIBC Asset Management Inc., as Manager of the Funds and Portfolios, will be making the following changes:

#### **CLOSING AND TERMINATION OF CLASSES**

Effective September 1, 2017, the Manager will close to all purchases certain classes of units of certain Funds and Portfolios.

Effective July 21, 2017, the Manager has closed to all purchases certain classes of units of certain Funds and Portfolios and will subsequently terminate these classes on or about October 13, 2017.

## MANAGEMENT FEE REDUCTIONS

Effective September 1, 2017, the maximum annual management fee in respect of certain classes of units of the Funds will be reduced.

## MINIMUM INVESTMENT REDUCTION

Effective September 1, 2017, the Manager will reduce the minimum investment amount in respect of certain classes of units of the Portfolios.

As a result, the Simplified Prospectus is amended as set out below.

#### SPECIFIC AMENDMENTS

## 1. CLOSING AND TERMINATION OF CLASSES

The Manager is making changes to certain classes of units of certain Funds and Portfolios, to either:

- Close the class to all purchases ("Closed to purchases") effective September 1, 2017; or
- Terminate the class ("Terminate") on or about October 13, 2017 (the "effective termination date").

Effective July 21, 2017, all terminating classes are closed to all purchases and will subsequently be terminated on or about October 13, 2017. Unitholders of a terminating class will have the right to redeem or switch units of the class up to the close of business on the business day immediately before the effective termination date.

Unitholders of a class that will be terminated will be provided written notice at least 60 days prior to the effective termination date. Unitholders who are still invested within a:

- registered account on the effective termination date will have all of their units switched to units of Renaissance Money Market Fund, or for funds denominated in U.S. dollars, to Renaissance U.S. Money Market Fund.
- non-registered account on the effective termination date will have all of their units redeemed and receive the cash amount equal to the relevant class' NAV per unit that day.

# (c) OPTIONAL SERVICES

Effective September 1, 2017 the disclosure in the table under the heading "Systematic Withdrawal Plan" on page 21 in Part A of the Simplified Prospectus, under the section "Portfolios" in respect of each of the following available classes is deleted and replaced as follows:

## **PURCHASERS' STATUTORY RIGHTS**

Securities legislation in some provinces and territories gives you the right to withdraw from an agreement to buy mutual funds within two business days of receiving the Simplified Prospectus or Fund Facts, or to cancel your purchase within 48 hours of receiving confirmation of your order. For a pre-authorized investment plan, you do not have this withdrawal right with respect to purchases of mutual fund units (after the initial purchase) where you do not request to receive subsequent Fund Facts and amendments.

Securities legislation in some provinces and territories also allows you to cancel an agreement to buy mutual fund units and get your money back, or to make a claim for damages, if the Simplified Prospectus, Annual Information Form, Fund Facts, or financial statements misrepresent any facts about the mutual fund units. These rights must usually be exercised within certain time limits. For more information, refer to the securities legislation of your province or territory, or consult your lawyer.
