Management Discussion of Fund Performance

Investment Objective and Strategies

Investment Objective: Renaissance Canadian Small-Cap Fund (the *Fund*) seeks above-average, long-term growth of capital by investing primarily in a diversified portfolio of equity securities of small- to medium-sized Canadian issuers.

Investment Strategies: The Fund invests in equity securities of small- to medium-sized Canadian and foreign issuers and may also invest in illiquid investments, such as restricted securities.

Risk

The Fund is a Canadian small/mid-cap equity fund that is suitable for long-term investors who can tolerate medium to high investment risk.

For the period ended August 31, 2018, the Fund's overall level of risk remains as discussed in the simplified prospectus.

Results of Operations

The Fund's portfolio advisor is CIBC Asset Management Inc. (*CAMI*, the *Manager* or *Portfolio Advisor*). The commentary that follows provides a summary of the results of operations for the period ended August 31, 2018. All dollar figures are expressed in thousands, unless otherwise indicated.

The Fund's net asset value decreased by 21% during the period, from \$171,409 as at August 31, 2017 to \$134,636 as at August 31, 2018. Net redemptions of \$35,957 and negative investment performance resulted in an overall decrease in net asset value.

Class A units of the Fund posted a return of -2.0% for the period. The Fund's benchmark, the S&P/TSX Small Cap Index (the *benchmark*), returned 3.5% for the same period. The Fund's return is after the deduction of fees and expenses, unlike the benchmark's return. See *Past Performance* for the returns of other classes of units offered by the Fund.

Gold prices declined towards the end of the period, creating challenges for gold companies. Despite the relative strength of oil prices, many Canadian oil producers struggled to get full value for

their product as a result of limited access and a lack of pipeline capacity.

Stock selection in the energy, real estate and industrials sectors detracted from the Fund's performance. Significant individual detractors included Element Fleet Management Corp., Alamos Gold Inc. and Clearwater Seafoods Inc.

Element Fleet Management underperformed as a result of integration challenges and uncertainty regarding the viability of its joint venture with 19th Capital Group LLC. Alamos Gold's share price declined after the company posted relatively weak results amid increasing costs and political uncertainty in Turkey. Clearwater Seafoods unexpectedly lost 25% of its clam quota, which was reallocated to a First Nations group. This, combined with pricing issues and reductions in total allowable catch across several species, contributed to the company's challenges.

Stock selection in the consumer discretionary and utilities sectors contributed to the Fund's performance. A moderate overweight allocation to the information technology sector also contributed to performance. Significant individual contributors included Orocobre Ltd., Pure Technologies Ltd. and Park Lawn Corp.

Orocobre's share price rose by about 55% as lithium prices continued to increase. Pure Technologies' share price rose by about 65% after the company received a takeover offer from Xylem Inc. Park Lawn's share price rose by more than 50% as a result of the strong execution of its growth-by-acquisition strategy.

The Portfolio Advisor added several new holdings to the Fund. Horizon North Logistics Inc. was purchased as the Portfolio Advisor expects it to benefit from the increased use of modular construction and the pending LNG Canada final investment decision. Akumin Inc., a company that operates medical imaging centres in the U.S., was added as the Portfolio Advisor believes that it is well positioned to consolidate its industry and build upon its platform.

Champion Iron Ltd., which produces high-grade iron ore from its mine on the Quebec–Labrador border, was also added to the Fund. The Portfolio Advisor believes that there should be strong demand for high-quality iron ore in Asia, and the company should be able to expand its operations in the coming years. The Portfolio Advisor increased the Fund's existing holding in Richelieu Hardware Ltd. following a decline in its stock price.

The Portfolio Advisor sold the Fund's holding in Clearwater Seafoods after it became clear that the company's issues were not temporary and that its debt levels were going to become a greater focus for investors. Dirt Environmental Solutions Ltd. was sold following a change in management. The Portfolio Advisor believes that there is increased risk in the execution on the company's growth strategy. The Portfolio Advisor also exited Brookfield Business Partners L.P. as its market capitalization increased beyond the Fund's limit.

The Portfolio Advisor trimmed the Fund's holdings in Spin Master Corp. and Kirkland Lake Gold Ltd. Both stocks had outperformed, approaching the upper boundary of the Fund's market capitalization limit.

Recent Developments

There were no recent events or activities that had a material impact on the Fund.

Related Party Transactions

CIBC and its affiliates have the following roles and responsibilities with respect to the Fund, and receive the fees described below in connection with their roles and responsibilities.

Manager, Trustee, and Portfolio Advisor of the Fund

CAMI, a wholly-owned subsidiary of CIBC, is the Fund's Manager, Trustee, and Portfolio Advisor. CAMI receives management fees with respect to the Fund's day-to-day business and operations, calculated based on the net asset value of each respective class of units of the Fund as described in *Management Fees*. As Trustee, CAMI holds title to the Fund's property (cash and securities) on behalf of its unitholders. As Portfolio Advisor, CAMI provides, or arranges to provide, investment advice and portfolio management services to the Fund. CAMI also compensates dealers in connection with their marketing activities regarding the Fund. From time to time, CAMI may invest in units of the Fund.

Distributor

Dealers and other firms sell units of the Fund to investors. These dealers and other firms include CAMI's related dealers such as the CIBC Investor's Edge discount brokerage division of CIBC Investor Services Inc. (*CIBC ISI*), the CIBC Imperial Service division of CIBC ISI, and the CIBC Wood Gundy division of CIBC World Markets Inc. (*CIBC WM*). CIBC ISI and CIBC WM are wholly-owned subsidiaries of CIBC.

CAMI may pay sales commissions and trailing commissions to these dealers and firms in connection with the sale of units of the Fund. These dealers and other firms may pay a portion of these sales

commissions and trailing commissions to their advisors who sell units of the Fund to investors.

Brokerage Arrangements and Soft Dollars

The Portfolio Advisor makes decisions, including the selection of markets and dealers and the negotiation of commissions, with respect to the purchase and sale of portfolio securities, certain derivative products and the execution of portfolio transactions. Brokerage business may be allocated by the Portfolio Advisor to CIBC WM and CIBC World Markets Corp., each a subsidiary of CIBC. CIBC WM and CIBC World Markets Corp. may also earn spreads on the sale of fixed income securities, other securities, and certain derivative products to the Fund. A spread is the difference between the bid and ask prices for a security in the applicable marketplace, with respect to the execution of portfolio transactions. The spread will differ based upon various factors such as the nature and liquidity of the security.

Dealers, including CIBC WM and CIBC World Markets Corp., may furnish goods and services, other than order execution, when CAMI processes trades through them (referred to in the industry as "soft-dollar" arrangements). These goods and services are paid for with a portion of brokerage commissions and assist CAMI with investment decision-making services for the Fund or relate directly to the execution of portfolio transactions on behalf of the Fund.

The fees and spreads for services of the Custodian directly related to the execution of portfolio transactions by the Fund are paid by CAMI and/or dealer(s) directed by CAMI, up to the amount of the credits generated under soft dollar arrangements from trading on behalf of the Fund during that month.

In addition, the Manager may enter into commission recapture arrangements with certain dealers with respect to the Fund. Any commission recaptured will be paid to the Fund.

During the period, the Fund paid brokerage commissions and other fees of \$41,680 to CIBC WM; the Fund did not pay any brokerage commissions or other fees to CIBC World Markets Corp. Spreads associated with fixed income and other securities are not ascertainable and, for that reason, cannot be included when determining these amounts.

Fund Transactions

The Fund may enter into one or more of the following transactions (the *Related Party Transactions*) in reliance on the standing instructions issued by the Independent Review Committee (*IRC*):

- invest in or hold equity securities of CIBC or issuers related to a portfolio sub-advisor;
- invest in or hold non-exchange-traded debt securities of CIBC or an issuer related to CIBC in a primary offering and in the secondary market;
- make an investment in the securities of an issuer for which CIBC WM, CIBC World Markets Corp., or any affiliate of CIBC (a *Related Dealer*) acts as an underwriter during the offering of the securities at any time during the 60-day period following the completion of the

offering of such securities (in the case of a “private placement” offering, in accordance with the exemptive relief order granted by the Canadian securities regulatory authorities and in accordance with the policies and procedures relating to such investment);

- purchase equity or debt securities from or sell them to a Related Dealer, where it is acting as principal;
- undertake currency and currency derivative transactions where a Related Dealer is the counterparty; and
- purchase securities from or sell securities to another investment fund or a managed account managed by the Manager or an affiliate of the Manager.

At least annually, the IRC reviews the Related Party Transactions for which they have issued standing instructions. The IRC is required to advise the Canadian securities regulatory authorities, after a matter has been referred to or reported to it by the Manager, if it determines that an investment decision was not made in accordance with conditions imposed by securities legislation or the IRC in any Related Party Transactions requiring its approval.

Custodian

CIBC Mellon Trust Company is the custodian of the Fund (the *Custodian*). The Custodian holds all cash and securities for the Fund and ensures that those assets are kept separate from any other cash or securities that the custodian might be holding. The Custodian also provides other services to the Fund including record-keeping and processing of foreign exchange transactions. The fees and spreads for services of the Custodian directly related to the execution of portfolio transactions by the Fund are paid by CAMI and/or dealer(s) directed by CAMI, up to the amount of the credits generated under soft dollar arrangements from trading on behalf of the Fund during that month. All other fees and spreads for the services of the Custodian are paid by the Manager and charged to the Fund on a recoverable basis. CIBC owns a 50% interest in the Custodian.

Service Provider

CIBC Mellon Global Securities Services Company (*CIBC GSS*) provides certain services to the Fund, including securities lending, fund accounting and reporting, and portfolio valuation. Such servicing fees are paid by the Manager and charged to the Fund on a recoverable basis. CIBC indirectly owns a 50% interest in CIBC GSS.

Management Fees

The Fund pays CAMI an annual management fee to cover the costs of managing the Fund. Management fees are based on the Fund's net asset value and are calculated daily and paid monthly. Management fees are paid to CAMI in consideration for providing, or arranging for the provision of, management, distribution, and portfolio advisory services. Advertising and promotional expenses, office overhead expenses related to the Manager's activities, and trailing commissions are paid by CAMI out of the management fees received from the Fund. The Fund is required to pay applicable taxes on the management fees paid to CAMI. Refer to the simplified prospectus for the annual management fee rate for each class of units.

For Class O units, the management fee is negotiated with and paid by, or as directed by, unitholders or dealers and discretionary managers on behalf of unitholders. Such Class O management fee will not exceed the Class F unit management fee rate.

The following table shows a breakdown of the services received in consideration of the management fees, as a percentage of the management fees collected from the Fund for the period ended August 31, 2018. These amounts do not include waived fees or absorbed expenses.

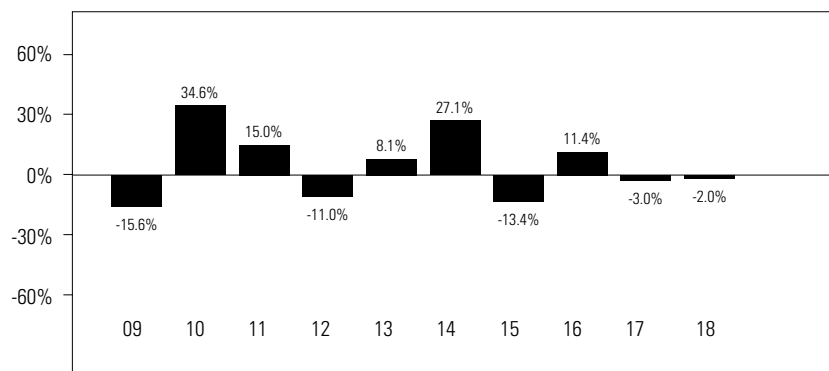

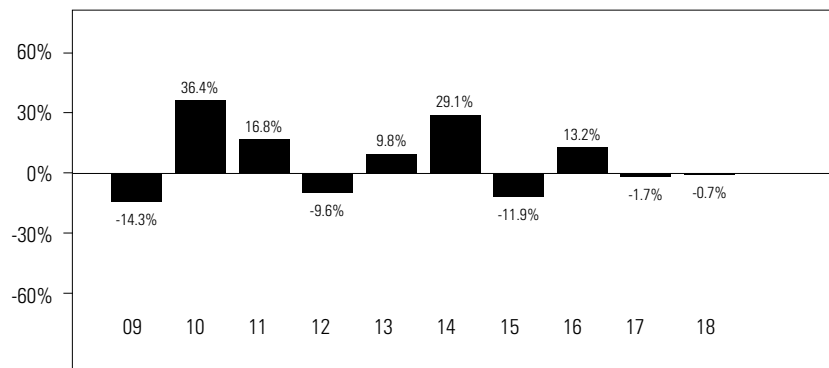

Class A Units

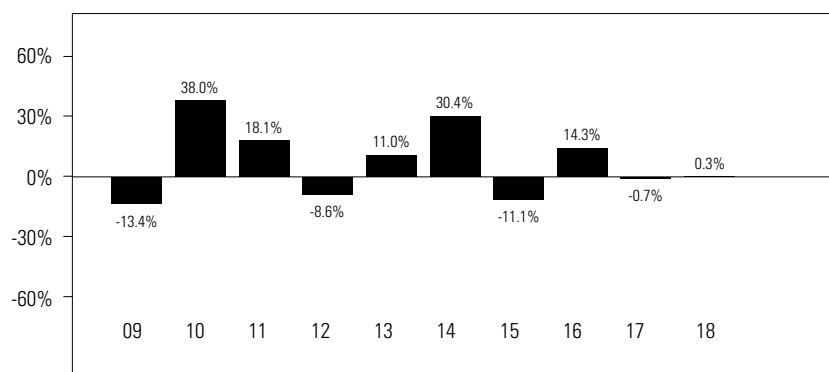


Renaissance Canadian Small-Cap Fund
