Management Discussion of Fund Performance

Investment Objective and Strategies

Investment Objective: Renaissance Optimal Global Equity Currency Neutral Portfolio (the *Fund*) seeks long-term capital growth primarily in units of global and/or Canadian mutual funds (the *Underlying Funds*). The Fund will attempt to reduce its currency exposure to non-Canadian dollar currencies by implementing a currency hedging strategy.

Investment Strategies: The Fund invests primarily in units of mutual funds managed by us or our affiliates and attempts to reduce its currency exposure to non-Canadian dollar currencies by implementing a currency hedging strategy that is aimed at protecting the Fund from non-Canadian dollar currency fluctuations in respect of units it owns in the *Underlying Funds*. The Fund may not be able to hedge its currency exposure fully and therefore could be subject to some foreign currency exposure.

Risk

The Fund is a global equity fund that is suitable for long-term investors who can tolerate medium investment risk.

For the period ended August 31, 2018, the Fund's overall level of risk remains as discussed in the simplified prospectus.

Results of Operations

The Fund's portfolio advisor is CIBC Asset Management Inc. (*CAMI*, the *Manager*, or *Portfolio Advisor*). The Fund invests in a combination of direct investments in other mutual funds (individually, an *Underlying Fund*, and collectively, the *Underlying Funds*) which can be found in the Top Positions table of the Summary of Investment Portfolio.

The commentary that follows provides a summary of the results of operations for the period ended August 31, 2018. All dollar figures are expressed in thousands, unless otherwise indicated.

The Fund's net asset value decreased by 31% during the period, from \$2,542 as at August 31, 2017 to \$1,760 as at August 31, 2018. Net redemptions of \$731 were partially offset by positive investment performance, resulting in an overall decrease in net asset value.

Class A units of the Fund posted a return of 10.6% for the period. The Fund's benchmark, the MSCI World Index (local currency) (the *benchmark*), returned 14.7% for the same period. The Fund's return is after the deduction of fees and expenses, unlike the benchmark's return. See *Past Performance* for the returns of other classes of units offered by the Fund.

Global equity markets were relatively strong over the period, driven by the U.S., Japan and the U.K. Conversely, equity markets in Spain, Italy and Sweden had the weakest performances. Small-capitalization stocks generally outperformed large-cap stocks.

Strong corporate profits, large share buybacks and fiscal stimulus supported U.S. equities. The U.S. accounted for nearly 85% of global equity market returns. U.S. economic data for the second quarter of 2018 indicated significant growth. Although global trade tensions dominated the headlines, they did not seem to weigh on U.S. business sentiment. The U.S. manufacturing sector showed strength, supported by rising output and new orders. The U.S. Federal Reserve Board indicated in August that it would continue to raise interest rates at a gradual pace.

Non-U.S. developed markets stocks posted positive performance, despite concerns about moderating economic growth in Europe and Japan, increased global political uncertainty and escalating trade tensions that contributed to volatility. The U.S. announced new steel and aluminum tariffs, as well as bilateral tariffs targeting more than \$50 billion USD in Chinese imports. China then announced retaliatory tariffs, the economic impact of which remains uncertain. However, these trade tensions contributed to concerns that tariffs could dampen global economic growth.

European equities rebounded during the first half of the period before geopolitical concerns and weakening economic data early in 2018 began to weigh on investor confidence. Despite political concerns, earnings results in Europe towards the end of the period were better than expected, and corporate sentiment remained positive.

The eurozone economy grew at a weaker-than-expected 0.4% in the first quarter, but second-quarter gross domestic product growth was revised upward. Eurozone growth rates improved slightly in both manufacturing and services, and job growth was robust. Despite these positive indicators, core inflation remained low and the European Central Bank indicated that it would likely keep interest rates steady until mid-2019.

Political concerns weighed on Italian equities. European banks exposed to Turkey's financial issues were also negatively affected, particularly Spanish banks. In the U.K., negotiations for its exit from the European Union proceeded, although the border with Ireland remained an unresolved issue.

Japanese equities gained overall for the period. Japanese private consumption rebounded in the second quarter, bolstered by strong wage growth, the highest in over 20 years. However, core inflation remained low and well below the Bank of Japan's target. In late July, Japan's central bank announced a more flexible bond-buying plan that would allow policymakers to adjust purchases according to market conditions. The central bank kept its 10-year government bond yield target near 0% but said the yield could fluctuate depending on economic and price developments.

Later in the period, emerging markets underperformed developed markets, partly as a result of rising U.S. interest rates, a strong U.S. dollar and trade tensions between the U.S. and China. The ongoing trade tensions began to affect trade and output in China. Exports to the U.S. fell 2.5% from June to July, and fixed-asset investments were weaker than expected. China's foreign exchange reserves increased modestly in July, reflecting a rising U.S. dollar and limited capital outflows.

The infrastructure sub-sector, which tends to be less sensitive to economic growth, lagged the broader global equity market. The passing of U.S. tax-reform legislation was broadly neutral to infrastructure companies. The sub-sector does not benefit from tax reform as much as other sectors as the tax benefit is either passed through regulation to the users of the assets, or the asset already sits in a tax pass-through structure.

From an underlying fund perspective, Renaissance Global Value Fund was the most significant detractor from the Fund's performance relative to the blended benchmark, followed by Renaissance Global Infrastructure Fund.

From an underlying fund perspective, Renaissance Global Small-Cap Fund was the most significant contributor to the Fund's performance relative to the blended benchmark, followed by Renaissance Global Focus Fund and Renaissance Global Markets Fund.

Recent Developments

There were no recent events or activities that had a material impact on the Fund.

Related Party Transactions

CIBC and its affiliates have the following roles and responsibilities with respect to the Fund, and receive the fees described below in connection with their roles and responsibilities.

Manager, Trustee, and Portfolio Advisor of the Fund

CAMI, a wholly-owned subsidiary of CIBC, is the Fund's Manager, Trustee, and Portfolio Advisor. CAMI receives management fees with respect to the Fund's day-to-day business and operations, calculated based on the net asset value of each respective class of units of the Fund as described in *Management Fees*. As Trustee, CAMI holds title to the Fund's property (cash and securities) on behalf of its unitholders. As Portfolio Advisor, CAMI provides, or arranges to provide, investment advice and portfolio management services to the Fund. CAMI also compensates dealers in connection with their marketing activities regarding the Fund. From time to time, CAMI may invest in units of the Fund.

Distributor

Dealers and other firms sell units of the Fund to investors. These dealers and other firms include CAMI's related dealers such as the CIBC Investor's Edge discount brokerage division of CIBC Investor Services Inc. (*CIBC ISI*), the CIBC Imperial Service division of CIBC ISI, and the CIBC Wood Gundy division of CIBC World Markets Inc. (*CIBC WM*). CIBC ISI and CIBC WM are wholly-owned subsidiaries of CIBC.

CAMI may pay sales commissions and trailing commissions to these dealers and firms in connection with the sale of units of the Fund. These dealers and other firms may pay a portion of these sales commissions and trailing commissions to their advisors who sell units of the Fund to investors.

Brokerage Arrangements and Soft Dollars

The Portfolio Advisor makes decisions, including the selection of markets and dealers and the negotiation of commissions, with respect to the purchase and sale of portfolio securities, certain derivative products and the execution of portfolio transactions. Brokerage business may be allocated by the Portfolio Advisor to CIBC WM and CIBC World Markets Corp., each a subsidiary of CIBC. CIBC WM and CIBC World Markets Corp. may also earn spreads on the sale of fixed income securities, other securities, and certain derivative products to the Fund. A spread is the difference between the bid and ask prices for a security in the applicable marketplace, with respect to the execution of portfolio transactions. The spread will differ based upon various factors such as the nature and liquidity of the security.

Dealers, including CIBC WM and CIBC World Markets Corp., may furnish goods and services, other than order execution, when CAMI processes trades through them (referred to in the industry as "soft-dollar" arrangements). These goods and services are paid for with a portion of brokerage commissions and assist CAMI with investment decision-making services for the Fund or relate directly to the execution of portfolio transactions on behalf of the Fund.

The fees and spreads for services of the Custodian directly related to the execution of portfolio transactions by the Fund are paid by CAMI and/or dealer(s) directed by CAMI, up to the amount of the credits generated under soft dollar arrangements from trading on behalf of the Fund during that month.

In addition, the Manager may enter into commission recapture arrangements with certain dealers with respect to the Fund. Any commission recaptured will be paid to the Fund.

During the period, the Fund did not pay any brokerage commissions or other fees to CIBC WM or CIBC World Markets Corp. Spreads associated with fixed income and other securities are not ascertainable and, for that reason, cannot be included when determining these amounts.

Fund Transactions

The Fund may enter into the following transaction (the *Related Party Transaction*) in reliance on the standing instructions issued by the Independent Review Committee (*IRC*):

- invest in or hold equity securities of CIBC or issuers related to a portfolio sub-advisor;
- invest in or hold non-exchange-traded debt securities of CIBC or an issuer related to CIBC in a primary offering and in the secondary market;
- make an investment in the securities of an issuer for which CIBC WM, CIBC World Markets Corp., or any affiliate of CIBC (a Related Dealer) acts as an underwriter during the offering of the securities at any time during the 60-day period following the completion of the offering of such securities (in the case of a "private placement" offering, in accordance with the exemptive relief order granted by the Canadian securities regulatory authorities and in accordance with the policies and procedures relating to such investment);
- purchase equity or debt securities from or sell them to a Related Dealer, where it is acting as principal;
- undertake currency and currency derivative transactions where a Related Dealer is the counterparty; and
- purchase securities from or sell securities to another investment fund or a managed account managed by the Manager or an affiliate of the Manager.

At least annually, the IRC reviews the Related Party Transactions for which they have issued standing instructions. The IRC is required to advise the Canadian securities regulatory authorities, after a matter has been referred to or reported to it by the Manager, if it determines that an investment decision was not made in accordance with conditions imposed by securities legislation or the IRC in any Related Party Transactions requiring its approval.

Custodian

CIBC Mellon Trust Company is the custodian of the Fund (the *Custodian*). The Custodian holds all cash and securities for the Fund and ensures that those assets are kept separate from any other cash

or securities that the custodian might be holding. The Custodian also provides other services to the Fund including record-keeping and processing of foreign exchange transactions. The fees and spreads for services of the Custodian directly related to the execution of portfolio transactions by the Fund are paid by CAMI and/or dealer(s) directed by CAMI, up to the amount of the credits generated under soft dollar arrangements from trading on behalf of the Fund during that month. All other fees and spreads for the services of the Custodian are paid by the Manager and charged to the Fund on a recoverable basis. CIBC owns a 50% interest in the Custodian.

Service Provider

CIBC Mellon Global Securities Services Company (*CIBC GSS*) provides certain services to the Fund, including securities lending, fund accounting and reporting, and portfolio valuation. Such servicing fees are paid by the Manager and charged to the Fund on a recoverable basis. CIBC indirectly owns a 50% interest in CIBC GSS.

Management Fees

The Fund pays CAMI an annual management fee to cover the costs of managing the Fund. Management fees are based on the Fund's net asset value and are calculated daily and paid monthly. Management fees are paid to CAMI in consideration for providing, or arranging for the provision of, management, distribution, and portfolio advisory services. Advertising and promotional expenses, office overhead expenses related to the Manager's activities, and trailing commissions are paid by CAMI out of the management fees received from the Fund. The Fund is required to pay applicable taxes on the management fees paid to CAMI. Refer to the simplified prospectus for the annual management fee rate for each class of units.

For Class O units, the management fee is negotiated with and paid by, or as directed by, unitholders or dealers and discretionary managers on behalf of unitholders. Such Class O management fee will not exceed the Class F unit management fee rate.

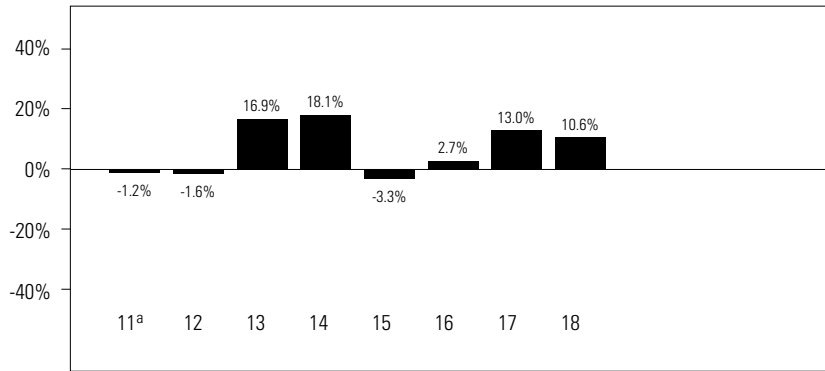

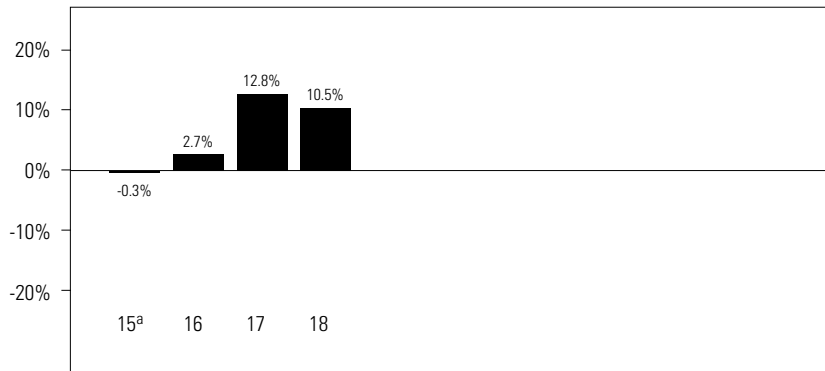
Renaissance Optimal Global Equity Currency Neutral Portfolio

Class A Units



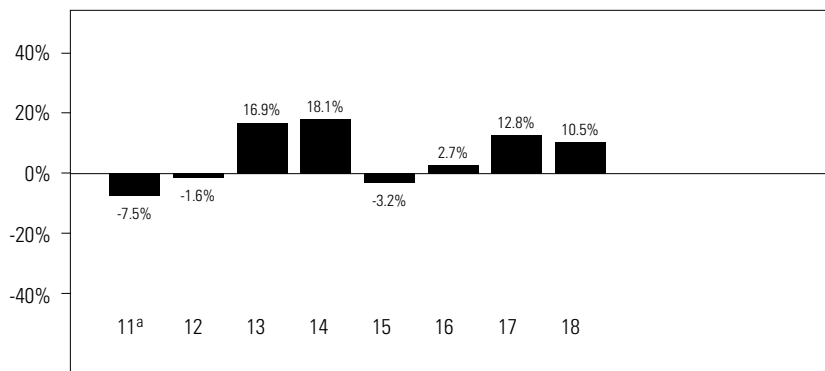

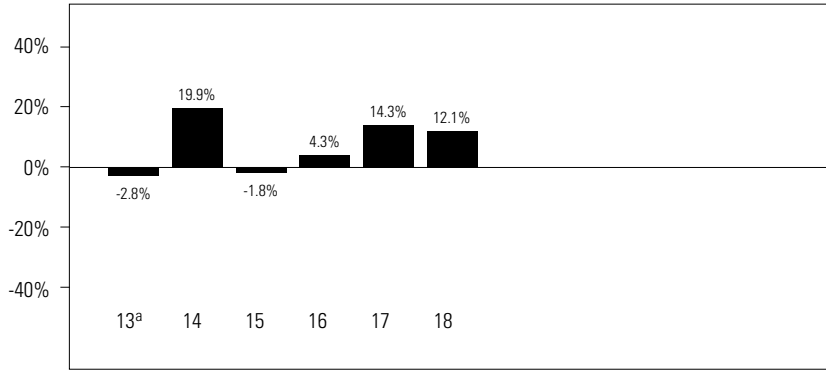
Class T6 Units

Class FT4 Units



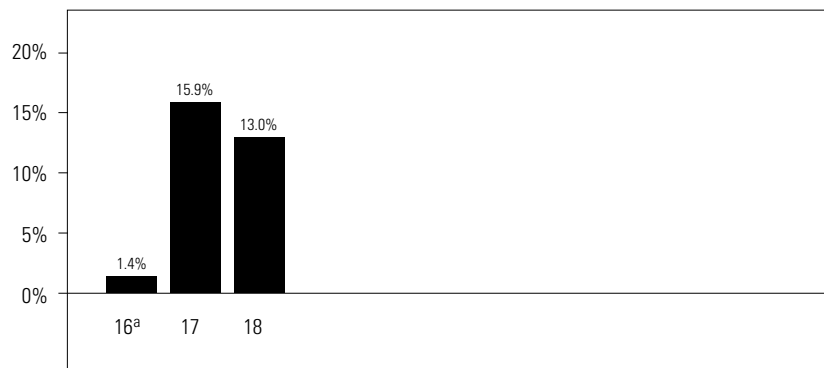
