Management Discussion of Fund Performance

Investment Objective and Strategies

Investment Objective: Renaissance Optimal Income Portfolio (the *Fund*) seeks to generate income with some potential for capital appreciation by investing primarily in units of Canadian and global mutual funds.

Investment Strategies: The Fund invests primarily in Canadian and global mutual funds managed by the Manager or its affiliates.

Risk

The Fund is a Canadian fixed income balanced fund that is suitable for medium- to long-term investors who can tolerate low investment risk.

For the period ended August 31, 2018, the Fund's overall level of risk remains as discussed in the simplified prospectus.

Results of Operations

The Fund invests in a combination of direct investments in other mutual funds (individually, an *Underlying Fund*, and collectively, the *Underlying Funds*) which can be found in the Top Positions table of the Summary of Investment Portfolio. The Fund's portfolio advisor is CIBC Asset Management Inc. (*CAMI*, the *Manager* or *Portfolio Advisor*).

The commentary that follows provides a summary of the results of operations for the period ended August 31, 2018. All dollar figures are expressed in thousands, unless otherwise indicated.

The Fund's net asset value decreased by 15% during the period, from \$3,106,059 as at August 31, 2017 to \$2,624,916 as at August 31, 2018. Net redemptions of \$474,188 were partially offset by positive investment performance, resulting in an overall decrease in net asset value.

Class A units of the Fund posted a return of 0.7% for the period. The Fund's primary benchmarks are the FTSE Canada Universe Bond Index and the S&P/TSX Composite Dividend Index (the *primary benchmarks*), which returned 1.3% and 9.7%, respectively, for the same period. The Fund's blended benchmark (the *blended*

benchmark) returned 5.9% for the same period. The blended benchmark closely reflects the asset classes in which the Fund invests, and is designed to provide a more useful comparative to the Fund's performance. The Fund's return is after the deduction of fees and expenses, unlike the primary and blended benchmarks' returns. See *Past Performance* for the returns of other classes of units offered by the Fund.

Over the period, the Bank of Canada (the *BoC*) raised its target overnight rate by 0.25% three times, largely in response to relatively strong economic conditions, including rising inflation and a low unemployment rate. Also contributing to the interest-rate increases was the BoC's positive outlook for domestic and global economic growth. However, certain risks, such as the ongoing renegotiations of the North American Free Trade Agreement and the Canadian economy's sensitivity to higher interest rates, tempered the BoC's outlook and future projections.

The U.S. Federal Reserve Board (the *Fed*) raised its federal funds rate by 0.25% three times, ultimately increasing the target range to 1.75%–2.00%. The Fed also began its balance sheet normalization process in October, and indicated that it could increase interest rates two more times in 2018.

Rising interest rates in both Canada and the U.S. resulted in higher bond yields across most of the yield curve. However, long-term bond yields remained stable, as inflation remained contained and demand for longer-duration (a measure of sensitivity to interest-rate changes) assets was strong. Trade tensions helped to limit the increase in long-term yields as investors became concerned that tariffs could lead to slower economic growth.

Corporate bond spreads (the difference in yields between corporate bonds and government bonds with similar maturities) were stable. This was a result of continued investor demand for higher yields than was available on government bonds.

A supply-and-demand imbalance, driven by demand for collateralized loan obligations and retail inflows, kept bank loan asset prices near

par. A supply-and-demand imbalance also contributed to a wave of re-pricing, which lowered average bond spreads, especially for higher-rated credits.

In the U.S., the high-yield bond market outperformed with positive returns. Credit markets, both investment grade and high yield, benefited from expectations of improving credit quality. As a result, credit spreads (the difference in yield between similar bonds with different credit ratings) tightened, which helped to offset the general rise in broad market bond yields.

Meanwhile, global bond markets were affected by moderating global growth and trade disputes. U.S.-dollar strength also had a significant impact on global currency and bond markets, but its effects were particularly negative for emerging markets, resulting in more challenging overall conditions for emerging market bonds.

In the Canadian equity market, valuations became more of a challenge, but the underlying operating results of Canadian businesses remained sound. There was increased caution in the Canadian housing market after housing prices in key markets rebounded and the Bank of Canada raised interest rates.

Uncertainty about the North American Free Trade Agreement negotiations resulted in heightened investor concerns. Trade issues dominated news headlines over the period. More specifically, protectionist trade policies and tariffs increased between the U.S. and its various trading partners. U.S. dollar strength resulted in weaker commodity prices, particularly for gold and copper.

Oil prices benefited from an improving supply and demand balance driven by growing demand and the Organization of the Petroleum Exporting Countries' production cuts. However, difficulties in getting heavy oil out of Western Canada resulted in wider price differentials for Canadian crude oil.

The infrastructure sub-sector, which tends to be less sensitive to economic growth, lagged the broader global equity market. The passing of U.S. tax-reform legislation was broadly neutral to infrastructure companies. The sub-sector does not benefit from tax reform as much as other sectors as the tax benefit is either passed through regulation to the users of the assets, or the asset already sits in a tax pass-through structure.

From an underlying fund perspective, Renaissance Canadian Dividend Fund was the most significant detractor from the Fund's performance relative to the blended benchmark, followed by Renaissance High-Yield Bond Fund and Renaissance Global Bond Fund.

From an underlying fund perspective, Renaissance Canadian Bond Fund was the most significant contributor to the Fund's performance relative to the blended benchmark, followed by Renaissance Floating Rate Income Fund.

Recent Developments

There were no recent events or activities that had a material impact on the Fund.

Related Party Transactions

CIBC and its affiliates have the following roles and responsibilities with respect to the Fund, and receive the fees described below in connection with their roles and responsibilities.

Manager, Trustee, and Portfolio Advisor of the Fund

CAMI, a wholly-owned subsidiary of CIBC, is the Fund's Manager, Trustee, and Portfolio Advisor. CAMI receives management fees with respect to the Fund's day-to-day business and operations, calculated based on the net asset value of each respective class of units of the Fund as described in *Management Fees*. As Trustee, CAMI holds title to the Fund's property (cash and securities) on behalf of its unitholders. As Portfolio Advisor, CAMI provides, or arranges to provide, investment advice and portfolio management services to the Fund. CAMI also compensates dealers in connection with their marketing activities regarding the Fund. From time to time, CAMI may invest in units of the Fund.

Distributor

Dealers and other firms sell units of the Fund to investors. These dealers and other firms include CAMI's related dealers such as the CIBC Investor's Edge discount brokerage division of CIBC Investor Services Inc. (*CIBC ISI*), the CIBC Imperial Service division of CIBC ISI, and the CIBC Wood Gundy division of CIBC World Markets Inc. (*CIBC WM*). CIBC ISI and CIBC WM are wholly-owned subsidiaries of CIBC.

CAMI may pay sales commissions and trailing commissions to these dealers and firms in connection with the sale of units of the Fund. These dealers and other firms may pay a portion of these sales commissions and trailing commissions to their advisors who sell units of the Fund to investors.

Brokerage Arrangements and Soft Dollars

The Portfolio Advisor makes decisions, including the selection of markets and dealers and the negotiation of commissions, with respect to the purchase and sale of portfolio securities, certain derivative products and the execution of portfolio transactions. Brokerage business may be allocated by the Portfolio Advisor to CIBC WM and CIBC World Markets Corp., each a subsidiary of CIBC. CIBC WM and CIBC World Markets Corp. may also earn spreads on the sale of fixed income securities, other securities, and certain derivative products to the Fund. A spread is the difference between the bid and ask prices for a security in the applicable marketplace, with respect to the execution of portfolio transactions. The spread will differ based upon various factors such as the nature and liquidity of the security.

Dealers, including CIBC WM and CIBC World Markets Corp., may furnish goods and services, other than order execution, when CAMI processes trades through them (referred to in the industry as "soft-dollar" arrangements). These goods and services are paid for with a portion of brokerage commissions and assist CAMI with investment decision-making services for the Fund or relate directly to the execution of portfolio transactions on behalf of the Fund.

The fees and spreads for services of the Custodian directly related to the execution of portfolio transactions by the Fund are paid by CAMI and/or dealer(s) directed by CAMI, up to the amount of the credits generated under soft dollar arrangements from trading on behalf of the Fund during that month.

In addition, the Manager may enter into commission recapture arrangements with certain dealers with respect to the Fund. Any commission recaptured will be paid to the Fund.

During the period, the Fund did not pay any brokerage commissions or other fees to CIBC WM or CIBC World Markets Corp. Spreads associated with fixed income and other securities are not ascertainable and, for that reason, cannot be included when determining these amounts.

Fund Transactions

The Fund may enter into the following transaction (the *Related Party Transaction*) in reliance on the standing instructions issued by the Independent Review Committee (*IRC*):

- invest in or hold equity securities of CIBC or issuers related to a portfolio sub-advisor;
- invest in or hold non-exchange-traded debt securities of CIBC or an issuer related to CIBC in a primary offering and in the secondary market;
- make an investment in the securities of an issuer for which CIBC WM, CIBC World Markets Corp., or any affiliate of CIBC (a Related Dealer) acts as an underwriter during the offering of the securities at any time during the 60-day period following the completion of the offering of such securities (in the case of a “private placement” offering, in accordance with the exemptive relief order granted by the Canadian securities regulatory authorities and in accordance with the policies and procedures relating to such investment);
- purchase equity or debt securities from or sell them to a Related Dealer, where it is acting as principal;
- undertake currency and currency derivative transactions where a Related Dealer is the counterparty; and
- purchase securities from or sell securities to another investment fund or a managed account managed by the Manager or an affiliate of the Manager.

At least annually, the IRC reviews the Related Party Transactions for which they have issued standing instructions. The IRC is required to advise the Canadian securities regulatory authorities, after a matter has been referred to or reported to it by the Manager, if it determines that an investment decision was not made in accordance with conditions imposed by securities legislation or the IRC in any Related Party Transactions requiring its approval.

Custodian

CIBC Mellon Trust Company is the custodian of the Fund (the *Custodian*). The Custodian holds all cash and securities for the Fund and ensures that those assets are kept separate from any other cash

or securities that the custodian might be holding. The Custodian also provides other services to the Fund including record-keeping and processing of foreign exchange transactions. The fees and spreads for services of the Custodian directly related to the execution of portfolio transactions by the Fund are paid by CAMI and/or dealer(s) directed by CAMI, up to the amount of the credits generated under soft dollar arrangements from trading on behalf of the Fund during that month. All other fees and spreads for the services of the Custodian are paid by the Manager and charged to the Fund on a recoverable basis. CIBC owns a 50% interest in the Custodian.

Service Provider

CIBC Mellon Global Securities Services Company (*CIBC GSS*) provides certain services to the Fund, including securities lending, fund accounting and reporting, and portfolio valuation. Such servicing fees are paid by the Manager and charged to the Fund on a recoverable basis. CIBC indirectly owns a 50% interest in CIBC GSS.

Management Fees

The Fund pays CAMI an annual management fee to cover the costs of managing the Fund. Management fees are based on the Fund's net asset value and are calculated daily and paid monthly. Management fees are paid to CAMI in consideration for providing, or arranging for the provision of, management, distribution, and portfolio advisory services. Advertising and promotional expenses, office overhead expenses related to the Manager's activities, and trailing commissions are paid by CAMI out of the management fees received from the Fund. The Fund is required to pay applicable taxes on the management fees paid to CAMI. Refer to the simplified prospectus for the annual management fee rate for each class of units.

For Class O units, the management fee is negotiated with and paid by, or as directed by, unitholders or dealers and discretionary managers on behalf of unitholders. Such Class O management fee will not exceed the Class F unit management fee rate.

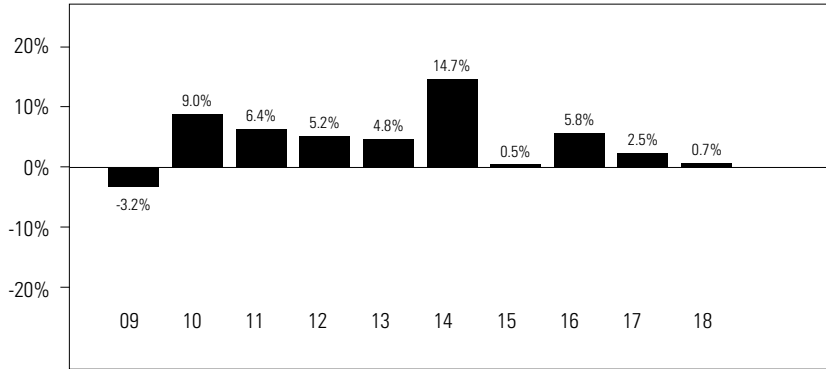

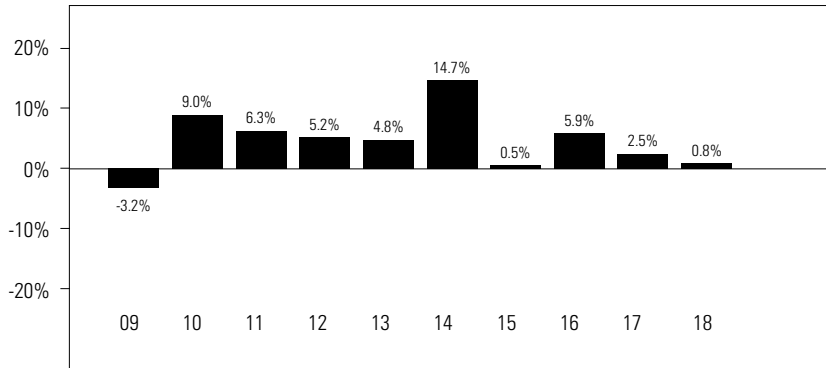

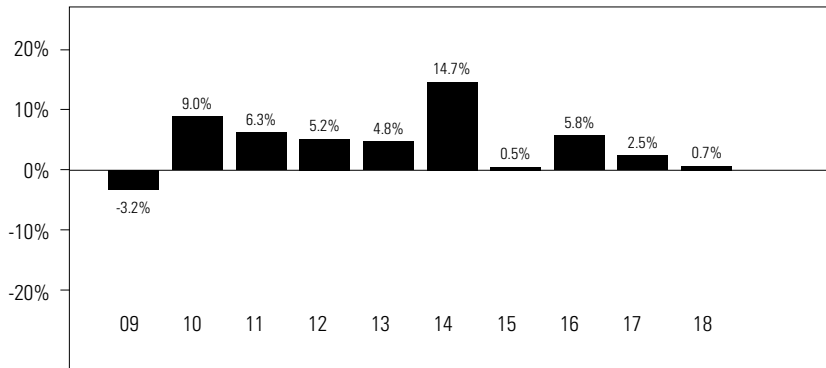

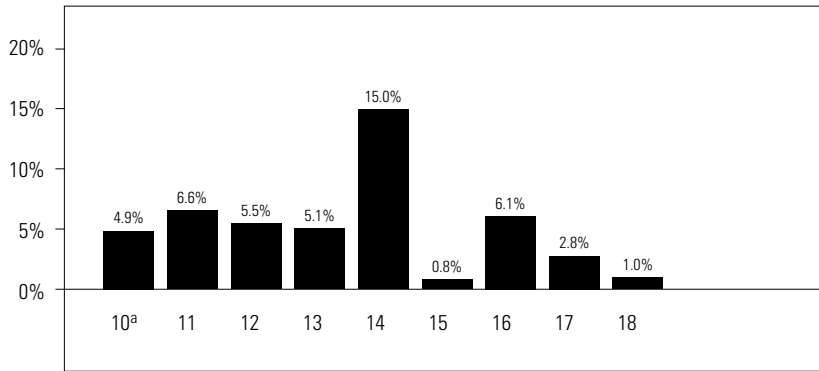

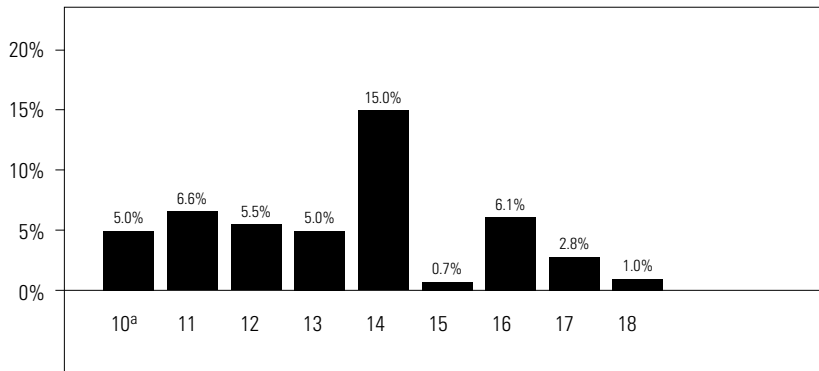

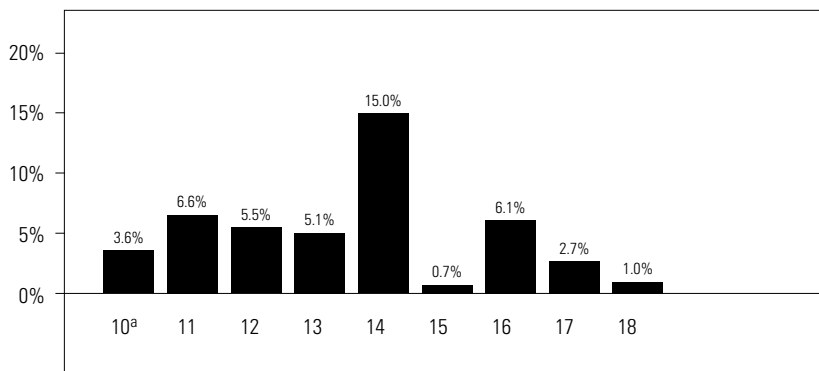

Select-T6 Class Units



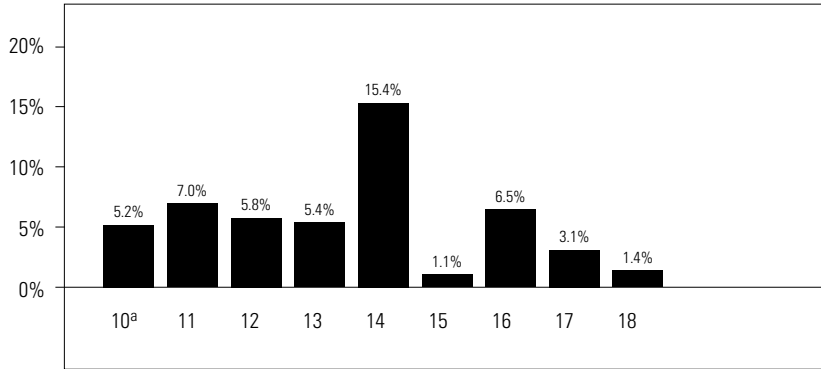

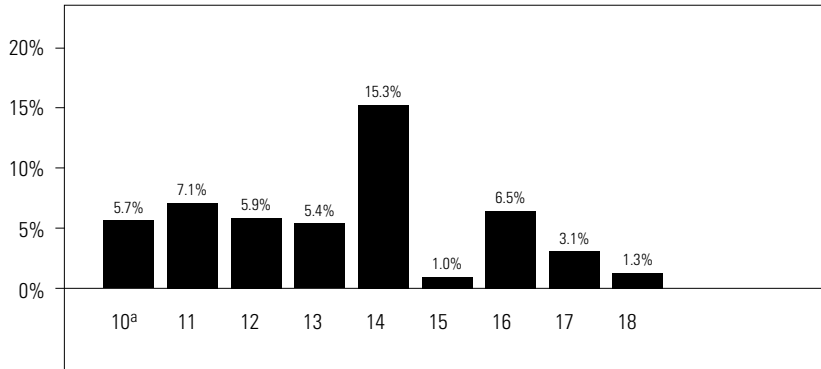

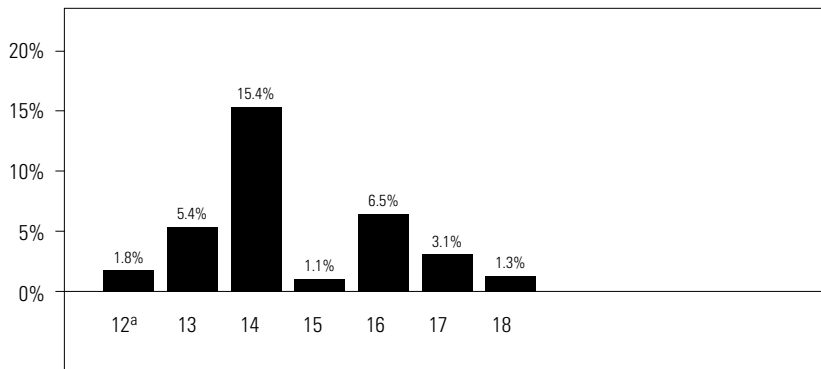

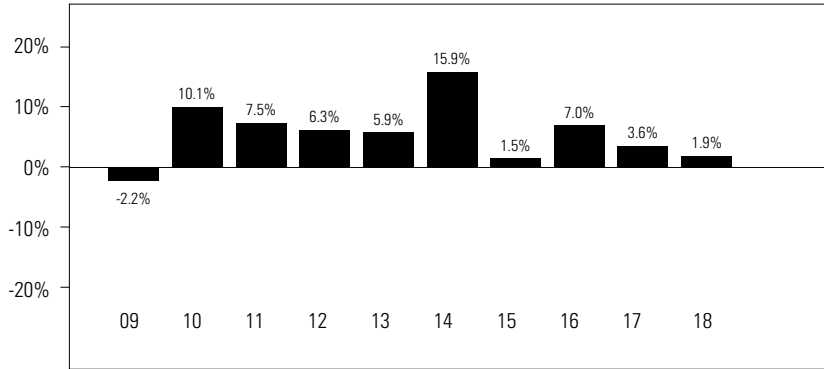

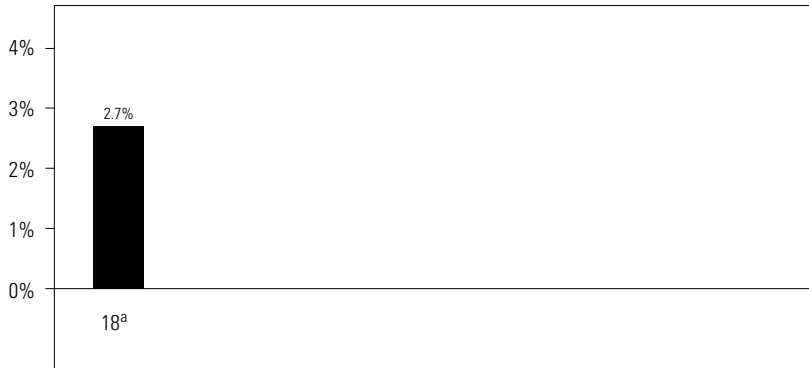

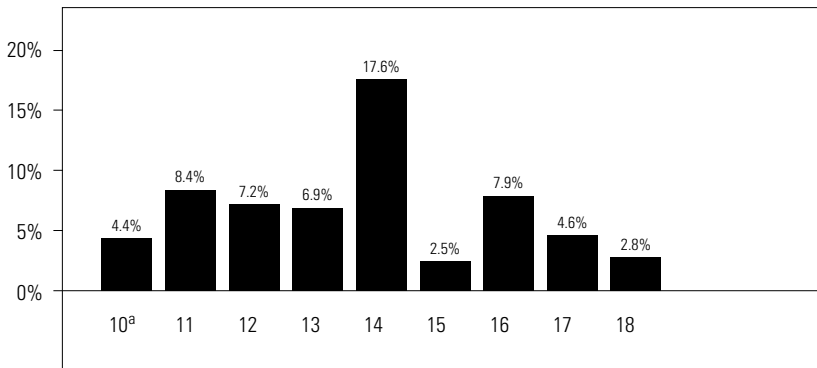
