

Annual Management Report of Fund Performance

Management Discussion of Fund Performance

Investment Objective and Strategies

Investment Objective: Renaissance U.S. Equity Fund (the *Fund*) seeks to achieve long-term capital growth by investing in equity securities of companies listed on major U.S. exchanges and/or domiciled primarily in the United States.

Investment Strategies: The Fund invests in common stocks from the Fund's benchmark, the S&P 500 Index. Stocks are selected for their potential contribution to long-term capital growth.

Risk

The Fund is a U.S. equity fund that is suitable for long-term investors who can tolerate medium investment risk.

For the period ended August 31, 2018, the Fund's overall level of risk remains as discussed in the simplified prospectus.

Results of Operations

The Fund's portfolio sub-advisor is INTECH Investment Management LLC (the *sub-advisor*). The commentary that follows provides a summary of the results of operations for the period ended August 31, 2018. All dollar figures are expressed in thousands, unless otherwise indicated.

The Fund's net asset value increased by 20% during the period, from \$52,323 as at August 31, 2017 to \$62,618 as at August 31, 2018. Positive investment performance was partially offset by net redemptions of \$1,189, resulting in an overall increase in net asset value.

Class A units of the Fund posted a return of 22.0% for the period. The Fund's benchmark, the S&P 500 Index (the *benchmark*), returned 24.5% for the same period. The Fund's return is after the deduction of fees and expenses, unlike the benchmark's return. See *Past Performance* for the return of the other class of units offered by the Fund.

Over the period, equity markets were strong, with most major indices moving toward record highs. Overall, U.S. equity market performance was relatively strong. Gains were fuelled by positive economic data,

including near-record-low unemployment levels. Gross domestic product growth exceeded expectations, while consumer confidence and manufacturing activity remained strong. The U.S. manufacturing sector showed strength, supported by rising output and new orders.

Uncertainty about the North American Free Trade Agreement negotiations resulted in heightened investor concerns globally. Trade issues dominated the news during the period, with an increase in protectionist rhetoric between the U.S. and its various trading partners. Oil prices benefited from an improving supply and demand balance driven by growing demand and the Organization of the Petroleum Exporting Countries' production cuts.

Despite solid overall performance, market volatility increased. The U.S. equity market posted its first negative quarterly return in nearly three years in the first quarter of 2018. However, the U.S. equity market recovered quickly, posting strong gains through the end of the period.

The strengthening U.S. economy led the U.S. Federal Reserve Board (the *Fed*) to gradually increase the federal funds target rate until August, when the Fed decided to keep the target rate in the 1.75% to 2.00% range.

The information technology sector continued to post strong gains, while utilities and consumer staples were the weakest-performing sectors. Energy prices were stronger than expected as a result of disrupted supply in Venezuela and Iran, and various geopolitical tensions. A bottleneck in the Permian basin prevented U.S. producers from increasing production promptly, which further benefited energy prices.

A moderate underweight allocation to the information technology sector, and moderate overweight exposure to the real estate sector, moderately detracted from the Fund's performance. As a result of their volatility and correlation characteristics, the Fund tends to have a bias toward the smaller stocks within the benchmark as they provide more relative volatility capture potential. As mega-capitalization stocks outperformed, the Fund's underweight allocation to mega-cap stocks

and overweight allocation to smaller-cap stocks moderately detracted from performance.

From an individual stock perspective, moderate underweight holdings in Amazon.com Inc., Microsoft Corp. and Apple Inc. were the most significant detractors from the Fund's performance. All three securities posted strong returns.

From a sector perspective, the Fund's underweight allocation to the consumer staples sector contributed moderately to performance, as it was one of the weakest-performing sectors. In addition, stock selection within the health care, industrials and information technology sectors also contributed moderately to the Fund's performance. Significant individual contributors to the Fund's performance included overweight allocations to Intuitive Surgical Inc., Micron Technology Inc. and The Boeing Co. All three holdings posted strong returns.

The sub-advisor's investment process does not select stocks based on their potential for future performance, but combines securities based on how their stock prices change relative to the benchmark. This is done in order to capture a rebalancing premium. Therefore, the positioning of the Fund versus the benchmark is driven by the search for stocks with high relative volatility and low correlation. Sales and purchases within the Fund's portfolio are the result of the sub-advisor's re-optimization and rebalancing strategy and are typically trims as opposed to adding or liquidating full holdings.

Recent Developments

There were no recent events or activities that had a material impact on the Fund.

Related Party Transactions

CIBC and its affiliates have the following roles and responsibilities with respect to the Fund, and receive the fees described below in connection with their roles and responsibilities.

Manager, Trustee, and Portfolio Advisor of the Fund

CAMI, a wholly-owned subsidiary of CIBC, is the Fund's Manager, Trustee, and Portfolio Advisor. CAMI receives management fees with respect to the Fund's day-to-day business and operations, calculated based on the net asset value of each respective class of units of the Fund as described in *Management Fees*. As Trustee, CAMI holds title to the Fund's property (cash and securities) on behalf of its unitholders. As Portfolio Advisor, CAMI provides, or arranges to provide, investment advice and portfolio management services to the Fund. CAMI also compensates dealers in connection with their marketing activities regarding the Fund. From time to time, CAMI may invest in units of the Fund.

Distributor

Dealers and other firms sell units of the Fund to investors. These dealers and other firms include CAMI's related dealers such as the CIBC Investor's Edge discount brokerage division of CIBC Investor Services Inc. (*CIBC ISI*), the CIBC Imperial Service division of CIBC ISI, and the CIBC Wood Gundy division of CIBC World Markets Inc.

(*CIBC WM*). CIBC ISI and CIBC WM are wholly-owned subsidiaries of CIBC.

CAMI may pay sales commissions and trailing commissions to these dealers and firms in connection with the sale of units of the Fund. These dealers and other firms may pay a portion of these sales commissions and trailing commissions to their advisors who sell units of the Fund to investors.

Brokerage Arrangements and Soft Dollars

CAMI generally delegates trading and execution authority to the portfolio sub-advisors and does not, in its capacity as portfolio advisor, receive any goods or services directly through soft dollar arrangements.

The Portfolio Advisor and any portfolio sub-advisors make decisions, including the selection of markets and dealers and the negotiation of commissions, with respect to the purchase and sale of portfolio securities, certain derivative products and the execution of portfolio transactions. Brokerage business may be allocated by the Portfolio Advisor and any portfolio sub-advisor to CIBC WM and CIBC World Markets Corp., each a subsidiary of CIBC. CIBC WM and CIBC World Markets Corp. may also earn spreads on the sale of fixed income securities, other securities, and certain derivative products to the Fund. A spread is the difference between the bid and ask prices for a security in the applicable marketplace, with respect to the execution of portfolio transactions. The spread will differ based upon various factors such as the nature and liquidity of the security.

Dealers, including CIBC WM and CIBC World Markets Corp., may furnish goods and services, other than order execution, to the Portfolio Advisor and any portfolio sub-advisors when they process trades through them (referred to in the industry as "soft-dollar" arrangements). These goods and services are paid for with a portion of the brokerage commissions and assist the Portfolio Advisor and any portfolio sub-advisor with investment decision-making services for the Fund or relate directly to the execution of portfolio transactions on behalf of the Fund. As per the terms of the portfolio sub-advisory agreements, such soft dollar arrangements are in compliance with applicable laws.

In addition, the Manager may enter into commission recapture arrangements with certain dealers with respect to the Fund. Any commission recaptured will be paid to the Fund.

During the period, the Fund did not pay any brokerage commissions or other fees to CIBC WM or CIBC World Markets Corp. Spreads associated with fixed income and other securities are not ascertainable and, for that reason, cannot be included when determining these amounts.

Fund Transactions

The Fund may enter into one or more of the following transactions (the *Related Party Transactions*) in reliance on the standing instructions issued by the Independent Review Committee (*IRC*):

- invest in or hold equity securities of CIBC or issuers related to a portfolio sub-advisor;

- invest in or hold non-exchange-traded debt securities of CIBC or an issuer related to CIBC in a primary offering and in the secondary market;
- make an investment in the securities of an issuer for which CIBC WM, CIBC World Markets Corp., or any affiliate of CIBC (a Related Dealer) acts as an underwriter during the offering of the securities at any time during the 60-day period following the completion of the offering of such securities (in the case of a “private placement” offering, in accordance with the exemptive relief order granted by the Canadian securities regulatory authorities and in accordance with the policies and procedures relating to such investment);
- purchase equity or debt securities from or sell them to a Related Dealer, where it is acting as principal;
- undertake currency and currency derivative transactions where a Related Dealer is the counterparty; and
- purchase securities from or sell securities to another investment fund or a managed account managed by the Manager or an affiliate of the Manager.

At least annually, the IRC reviews the Related Party Transactions for which they have issued standing instructions. The IRC is required to advise the Canadian securities regulatory authorities, after a matter has been referred to or reported to it by the Manager, if it determines that an investment decision was not made in accordance with conditions imposed by securities legislation or the IRC in any Related Party Transactions requiring its approval.

Custodian

CIBC Mellon Trust Company is the custodian of the Fund (the *Custodian*). The Custodian holds all cash and securities for the Fund and ensures that those assets are kept separate from any other cash or securities that the custodian might be holding. The Custodian also provides other services to the Fund including record-keeping and processing of foreign exchange transactions. The fees and spreads for services of the Custodian directly related to the execution of portfolio transactions by the Fund are paid by CAMI and/or dealer(s) directed by CAMI, up to the amount of the credits generated under soft dollar arrangements from trading on behalf of the Fund during that month. All other fees and spreads for the services of the Custodian are paid by the Manager and charged to the Fund on a recoverable basis. CIBC owns a 50% interest in the Custodian.

Service Provider

CIBC Mellon Global Securities Services Company (*CIBC GSS*) provides certain services to the Fund, including securities lending, fund accounting and reporting, and portfolio valuation. Such servicing fees are paid by the Manager and charged to the Fund on a recoverable basis. CIBC indirectly owns a 50% interest in CIBC GSS.

Management Fees

The Fund pays CAMI an annual management fee to cover the costs of managing the Fund. Management fees are based on the Fund's net asset value and are calculated daily and paid monthly. Management fees are paid to CAMI in consideration for providing, or arranging for the provision of, management, distribution, and portfolio advisory services. Advertising and promotional expenses, office overhead expenses, trailing commissions, and the fees of the portfolio sub-advisor are paid by CAMI out of the management fees received from the Fund. The Fund is required to pay applicable taxes on the management fees paid to CAMI. Refer to the simplified prospectus for the annual management fee rate for each class of units.

For Class O units, the management fee is negotiated with and paid by, or as directed by, unitholders or dealers and discretionary managers on behalf of unitholders. Such Class O management fee will not exceed the Class F unit management fee rate.

The following table shows a breakdown of the services received in consideration of the management fees, as a percentage of the management fees collected from the Fund for the period ended August 31, 2018. These amounts do not include waived fees or absorbed expenses.

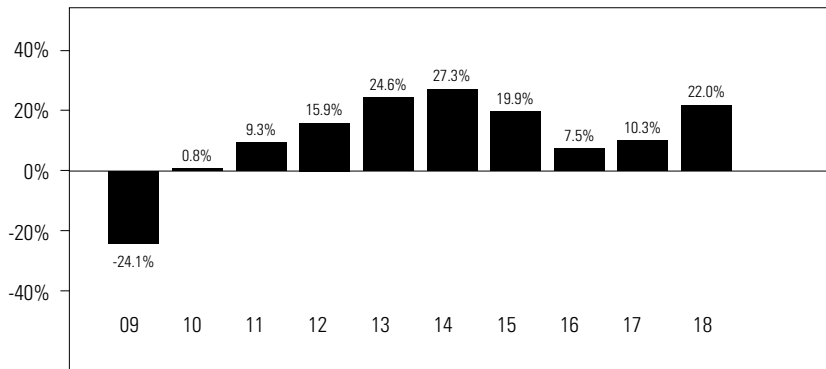

Year-by-Year Returns

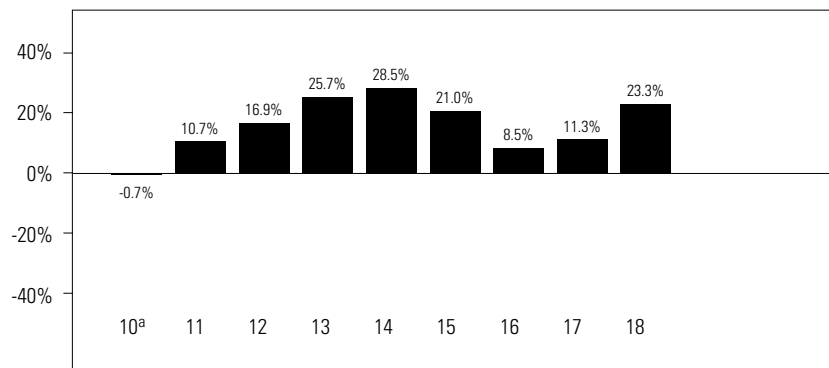

Class A Units



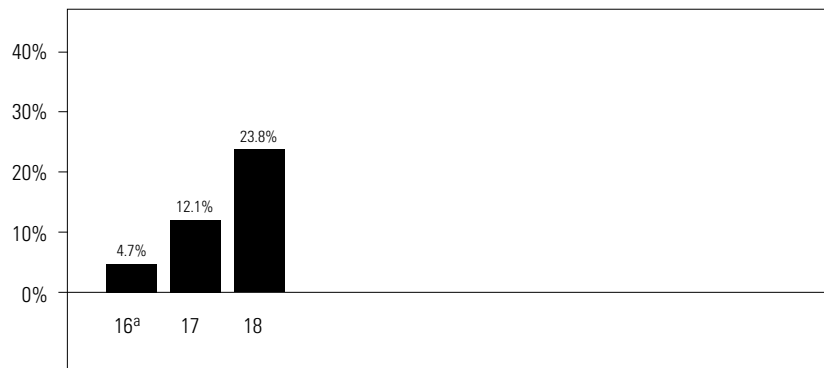
Renaissance U.S. Equity Fund
