Management Discussion of Fund Performance

Results of Operations

Renaissance Canadian Monthly Income Fund's (referred to as the *Fund*) Portfolio Advisor is CIBC Asset Management Inc. (referred to as *CAMI*, the *Manager* or the *Portfolio Advisor*). The commentary that follows provides a summary of the results of operations for the six-month period ended February 28, 2022. All dollar figures are expressed in thousands, unless otherwise indicated.

The Fund's net asset value decreased by 4% during the period, from \$56,664 as at August 31, 2021 to \$54,572 as at February 28, 2022. Net redemptions of \$1,093 and negative investment performance resulted in an overall decrease in net asset value.

Class A units of the Fund posted a return of -1.1% for the period. The Fund's benchmarks, the FTSE Canada Universe Bond Index and the S&P/TSX Composite Dividend Index (referred to as the *primary benchmarks*), returned -4.0% and 10.6%, respectively, for the same period. The Fund's return is after the deduction of fees and expenses, unlike the benchmarks' returns. See the section *Past Performance* for the return of the other class of units offered by the Fund.

The spread of the COVID-19 Omicron variant late in 2021 resulted in new lockdown restrictions. Despite these restrictions, the Canadian economy expanded at a relatively strong pace. The increase was driven by strong business inventory accumulation, along with higher residential investment. Consumer spending also advanced slightly. However, economic activity was pressured late in the period amid protests that slowed trade activity with the U.S. and added to supply-chain disruptions.

Geopolitical tensions in Ukraine grew as Russia built up its military presence around the country. Ultimately, Russia began a military invasion of Ukraine, which was answered with severe economic and financial sanctions from the West.

The Bank of Canada (referred to as the *BoC*) held its benchmark overnight interest rate steady at 0.25%, believing the Canadian economy still warranted monetary support. But the BoC did end its bond purchases, which were initiated at the onset of the pandemic. The U.S. Federal Reserve Board (referred to as the *Fed*) held the target range for its federal funds rate steady at 0.00%–0.25%. The Fed

began to slow its asset-purchase program, while suggesting an increase in interest rates was likely in response to surging inflation.

A slight underweight allocation to the materials sector detracted from performance as precious and base metals performed well. A slight underweight exposure to the utilities sector and a moderate overweight exposure to the industrials sector also detracted from the Fund's performance, as did stock selection within the information technology sector detracted from performance.

Individual detractors included Restaurant Brands International Inc., Netflix Inc., The Home Depot Inc. and Samsung SDI Co. Ltd. Pandemic-related store closures and delays in reopening caused weak operating results for Restaurant Brands International. Netflix missed its subscriber growth targets and was negatively affected by market pressure on the information technology sector from rising interest rates. Home Depot was adversely affected by rising interest rates, which weighed on most housing-related stocks, while higher commodity costs weighed on Samsung SDI's margins.

A moderate overweight allocation to the energy sector contributed to the Fund's performance. Higher commodity prices, along with growing demand, economic sanctions on Russia and limited supply, led to outperformance. A significant underweight exposure to the industrials sector also contributed to the Fund's performance. Though there was outperformance from the Fund's railway holdings, many other industrials stocks faced operational challenges as a result of supply-chain issues. A slight overweight allocation to the financials sector contributed to performance as well.

Individual contributors to the Fund's performance included The Toronto-Dominion Bank, Canadian Natural Resources Ltd., Cenovus Energy Inc. Chevron Corp. and LPL Financial Holdings Inc. The Toronto-Dominion Bank benefited as bank stocks rose amid stronger operating results. Energy companies Canadian Natural Resources and Cenovus Energy benefited from higher commodity prices and strong operating results, while Chevron Corp. also benefited as the result of rising crude oil prices. LPL Financial Holdings' management continued to execute well on winning assets and new mandates with continuing consolidation of advisor networks.

The Portfolio Advisor added several new holdings to the Fund. Deutsche Post AG was added as it is a high-quality supply-chain provider. A new holding in LVMH Moët Hennessy-Louis Vuitton SE was purchased given its turnaround opportunity on Tiffany & Co. Singapore Telecommunications Ltd. was added amid the improving competitive landscape and the company's cash flow outlook. It also adds defensive exposure to the Fund. A holding in Zebra Technologies Corp. was added with the proceeds of the sale of Keyence Corp. for its similar growth and position, but lower valuation.

Existing holdings in Bank of Montreal, The Toronto-Dominion Bank, Royal Bank of Canada and Enbridge Inc. were increased. The Portfolio Advisor used market volatility to add to existing holdings in strong businesses with improving outlooks. Netflix and Nestle OYJ were increased after an equity sell-off created an opportunity to add to the holdings at a lower price.

A holding in Cominar REIT was eliminated from the Fund as it was acquired by a consortium of buyers. Antofagasta PLC was eliminated based on geopolitical risks. A holding in Kerry Group PLC was eliminated as a source of funds for other opportunities. Las Vegas Sands Corp. was sold given rising risks in Macau licensing. Activision Blizzard Inc. was sold after it announced its acquisition by Microsoft Corp. A holding in American Tower Corp. was sold in favour of a new holding in Prologis Inc.

LPL Financial Holdings was trimmed to take profits. Sony Group Corp. was trimmed to fund other investment opportunities. Nutrien Ltd., Barrick Gold Corp., Finning International Inc. and Brookfield Asset Management Inc. were trimmed as their stock prices rose.

Recent Developments

The escalating conflict between Ukraine and the Russian Federation has resulted in significant volatility and uncertainty in financial markets. It is unclear what further actions may be taken by governments and the resulting impact on global economies, businesses, financial markets, and the Fund's performance. While the situation remains fluid, the Fund continues to monitor ongoing developments and the impact to investment strategies.

Effective September 1, 2021, CAMI, as Manager, pays the Fund's operating expenses, other than certain expenses, in exchange for the payment by the Fund of a fixed administration fee. This fee applies to all of the Fund's classes, other than Class O, and is equal to a specified percentage of the net asset value of each class of the Fund.

During the period, the Fund's blended benchmark was changed from 42.5% FTSE Canada Universe Bond Index, 40% S&P/TSX Composite Dividend Index, 10% MSCI World Index, 7.50% Bank of America Merrill Lynch BB-B U.S. Cash Pay High Yield Index (100% Hedged to CAD) to a blended benchmark comprised of 50% S&P/TSX Composite Dividend Index, 34% FTSE Canada Universe Bond Index, 10% MSCI World Index, 5.4% ICE Bank of America Merrill Lynch BB-B U.S. Cash Pay High Yield Index (100% Hedged in CAD) and 0.6% ICE Bank of America Merrill Lynch BB-B Canada High Yield Index. The current blended benchmark better reflects how the Fund is positioned.

The COVID-19 pandemic and the restrictions imposed by governments around the world to limit its spread have disrupted the global economy

and financial markets in unprecedented and unpredictable ways. The COVID-19 outbreak may adversely affect the performance of the Fund.

Related Party Transactions

Canadian Imperial Bank of Commerce (referred to as *CIBC*) and its affiliates have the following roles and responsibilities with respect to the Fund, and receive the fees described below in connection with their roles and responsibilities.

Manager, Trustee, and Portfolio Advisor of the Fund

CAMI, a wholly-owned subsidiary of CIBC, is the Fund's Manager, Trustee, and Portfolio Advisor. As Manager, CAMI receives management fees with respect to the Fund's day-to-day business and operations, calculated based on the net asset value of each respective class of units of the Fund as described in *Management Fees*.

The Manager pays the Fund's operating expenses (other than certain Fund costs) in respect of the classes of units of the Fund (except Class O unit), which may include but are not limited to, operating and administrative costs; regulatory fees; audit, and legal fees and expenses; trustee, safekeeping, custodial, and any agency fees; and investor servicing costs and costs of unitholder reports, prospectuses, Fund Facts, and other reports, in exchange for the Fund paying a fixed rate administration fee (plus applicable GST/HST) to the Manager with respect to those classes of units. For Class O units, no fixed administration fee will be charged. The Manager pays the Fund's operating expenses (other than certain Fund costs) allocated to Class O units of the Fund. The fixed administration fee payable by the Fund, may, in any particular period, exceed or be lower than the expenses we incur in providing such services to the Fund.

As Trustee, CAMI holds title to the Fund's property (cash and securities) on behalf of its unitholders. As Portfolio Advisor, CAMI provides, or arranges to provide for, investment advice and portfolio management services to the Fund. CAMI also compensates dealers in connection with their marketing activities regarding the Fund. From time to time, CAMI may invest in units of the Fund.

Distributor

Dealers and other firms sell units of the Fund to investors. These dealers and other firms include CAMI's related dealers such as the CIBC Investor's Edge discount brokerage division of CIBC Investor Services Inc. (referred to as *CIBC ISI*), the CIBC Imperial Service division of CIBC ISI, and the CIBC Wood Gundy division of CIBC World Markets Inc. (referred to as *CIBC WM*). CIBC ISI and CIBC WM are wholly-owned subsidiaries of CIBC.

CAMI may pay sales commissions and trailing commissions to these dealers and firms in connection with the sale of units of the Fund. These dealers and other firms may pay a portion of these sales commissions and trailing commissions to their advisors who sell units of the Fund to investors.

Brokerage Arrangements and Soft Dollars

The Portfolio Advisor and any portfolio sub-advisors make decisions, including the selection of markets and dealers and the negotiation of commissions, with respect to the purchase and sale of portfolio securities, certain derivative products and the execution of portfolio transactions. Brokerage business may be allocated by the Portfolio

Advisor and any portfolio sub-advisor to CIBC WM and CIBC World Markets Corp., each a subsidiary of CIBC. CIBC WM and CIBC World Markets Corp. may also earn spreads on the sale of fixed income securities, other securities, and certain derivative products to the Fund. A spread is the difference between the bid and ask prices for a security in the applicable marketplace, with respect to the execution of portfolio transactions. The spread will differ based upon various factors such as the nature and liquidity of the security.

Dealers, including CIBC WM and CIBC World Markets Corp., may furnish goods and services, other than order execution, to the Portfolio Advisor and any portfolio sub-advisors when they process trades through them (referred to in the industry as “soft-dollar” arrangements). These goods and services are paid for with a portion of the brokerage commissions and assist the Portfolio Advisor and any portfolio sub-advisor with investment decision-making services for the Fund or relate directly to the execution of portfolio transactions on behalf of the Fund. As per the terms of the portfolio sub-advisory agreements, such soft dollar arrangements are in compliance with applicable laws.

The fees and spreads for services of the Custodian directly related to the execution of portfolio transactions by the Fund are paid by CAMI and/or dealer(s) directed by CAMI, up to the amount of the credits generated under soft dollar arrangements from trading on behalf of the Fund during that month.

In addition, the Manager may enter into commission recapture arrangements with certain dealers with respect to the Fund. Any commission recaptured will be paid to the Fund.

During the period, the Fund paid brokerage commissions and other fees of \$1,281 to CIBC WM and \$45 to CIBC World Markets Corp. Spreads associated with fixed income and other securities are not ascertainable and, for that reason, cannot be included when determining these amounts.

Fund Transactions

The Fund may enter into one or more of the following transactions (referred to as the *Related Party Transactions*) in reliance on the standing instructions issued by the Independent Review Committee (referred to as the *IRC*):

- invest in or hold equity securities of CIBC or issuers related to a portfolio sub-advisor;
- invest in or hold non-exchange-traded debt securities of CIBC or an issuer related to CIBC, with terms-to-maturity of 365 days or more, issued in a primary offering and in the secondary market;
- make an investment in the securities of an issuer for which CIBC WM, CIBC World Markets Corp., or any affiliate of CIBC (referred to as a *Related Dealer* or the *Related Dealers*) acts as an underwriter during the offering of the securities or at any time during the 60-day period following the completion of the offering of such securities (in the case of a “private placement” offering, in accordance with the Private Placement Relief Order and the policies and procedures relating to such investment);
- purchase equity or debt securities from, or sell them to, a Related Dealer, where it is acting as principal;

- undertake currency and currency derivative transactions where a related party is the counterparty;
- purchase securities from or sell securities to another investment fund or a managed account managed by the Manager or an affiliate (referred to as *inter-fund trades* or *cross-trades*); and
- engage in in-specie transfers by receiving portfolio securities from, or delivering portfolio securities to, a managed account or another investment fund managed by the Manager or an affiliate, in respect of a purchase or redemption of units of the Fund, subject to certain conditions.

At least annually, the IRC reviews the Related Party Transactions for which they have issued standing instructions. The IRC is required to advise the Canadian securities regulatory authorities, after a matter has been referred to or reported to it by the Manager, if it determines that an investment decision was not made in accordance with conditions imposed by securities legislation or the IRC in any Related Party Transactions requiring its approval.

Custodian

CIBC Mellon Trust Company is the custodian of the Fund (referred to as the *Custodian*). The Custodian holds all cash and securities for the Fund and ensures that those assets are kept separate from any other cash or securities that the custodian might be holding. The Custodian also provides other services to the Fund including record-keeping and processing of foreign exchange transactions. The fees and spreads for services of the Custodian directly related to the execution of portfolio transactions by the Fund are paid by CAMI and/or dealer(s) directed by CAMI, up to the amount of the credits generated under soft dollar arrangements from trading on behalf of the Fund during that month. All other fees and spreads for the services of the Custodian are paid by the Manager. CIBC owns a 50% interest in the Custodian.

Service Provider

CIBC Mellon Global Securities Services Company (referred to as *CIBC GSS*) provides certain services to the Fund, including securities lending, fund accounting and reporting, and portfolio valuation. Such servicing fees are paid by the Manager. CIBC indirectly owns a 50% interest in CIBC GSS.

Management Fees

The Fund pays CAMI an annual management fee to cover the costs of managing the Fund. Management fees are based on the Fund's net asset value and are calculated daily and paid monthly. Management fees are paid to CAMI in consideration for providing, or arranging for the provision of, management, distribution, and portfolio advisory services. Advertising and promotional expenses, office overhead expenses, trailing commissions, and the fees of the portfolio sub-advisors are paid by CAMI out of the management fees received from the Fund. The Fund is required to pay applicable taxes on the management fees paid to CAMI. Refer to the simplified prospectus for the annual management fee rate for each class of units.

For Class O units, the management fee is negotiated with and paid by, or as directed by, unitholders or dealers and discretionary managers on behalf of unitholders. Such Class O management fee will not exceed the Class F unit management fee rate.

The following table shows a breakdown of the services received in consideration of the management fees, as a percentage of the management fees collected from the Fund for the period ended February 28, 2022. These amounts do not include waived fees or absorbed expenses.

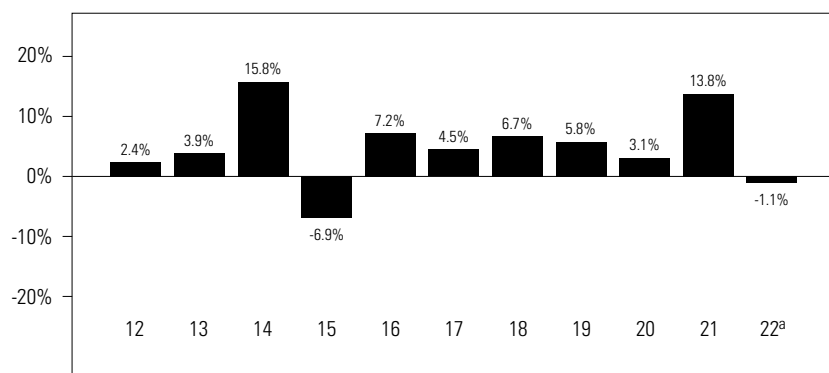

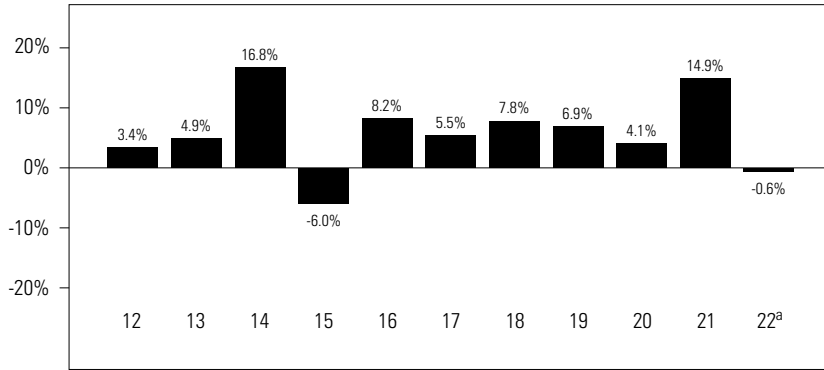
Class A Units

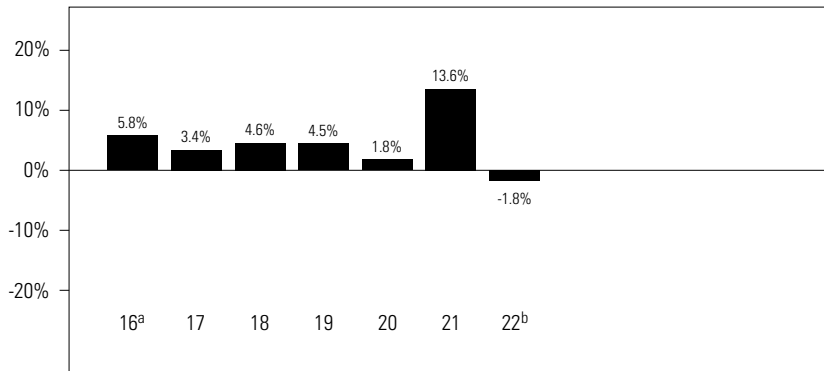
Renaissance Canadian Monthly Income Fund
