

Renaissance Investments Request to Unlock Funds from a Federal Restricted Life Income Fund ("Restricted LIF")

This request will not be valid and will not be acted upon if it is received by CIBC Trust or the Agent more than 60 days after the Restricted LIF was established. (A Restricted LIF is considered "established" when any locked-in funds are first received in the Restricted LIF.)

I wish to take advantage of the up-to-50% unlocking provision under the Legislation. I understand the following:

- Together with this request, I must provide a fully completed copy of the Attestation(s) Regarding Spouse/Common-law Partner form which is required by the Legislation. Without that, my request is incomplete; if any required form is provided after the 60 day period referred to above, my request cannot be processed.
- I must be turning age 55 or older in the calendar year that my Account is established to qualify for the up-to-50% unlocking provision.
- I may not unlock more than 50% of the value of my Account. This means the value of my Account, determined in accordance with the Restricted Life Income Fund Amending Agreement I signed when opening this Account, as of the date that the unlocking occurs (the "Value"). I understand that this Value may be different from the Account's value today or at any other time. If the amount I request is greater than 50% of the Value of my Account, then I will be deemed to have requested the unlocking of 50% of the Value of my Account.
- This unlocking provision is a one-time option. If I choose to unlock less than 50% of the Value of my Account, then I cannot unlock additional funds from this Restricted LIF at a later date.
- I must transfer the unlocked funds to a registered retirement savings plan ("RRSP") or a registered retirement income fund ("RRIF").
